

EVICTION PREVENTION RESOURCE GUIDE

You're probably reading this because you've received an eviction notice. This is a stressful time and this resource guide was designed to guide you through the next steps.

Follow These Steps:

- Take a deep breath.
- Apply for rental assistance.
- If you receive SSI, SSDI, or TANF benefits, let your landlord know this in writing to schedule mandatory mediation.
- Apply for legal assistance.
- · File an answer with legal support.
- If needed, plan to attend a court date which may involve asking for work off, printing evidence/ documentation, and arranging transportation.
- · Plan for the worst and hope for the best!

Rental Assistance



Almost Home, Inc. (www.almosthomeonline.org)

Emergency assistance and short-term case management to households in South Weld County below 80% at risk of eviction or foreclosure as well as to households at risk of utility shut-offs. **Get Connected:** apply on our website between 9-11 am on the 1st of every month

Provides non-perishable food assistance and financial assistance for rent and utilities to residents of the Weld County portion of the St. Vrain Valley School District

DHS - Housing Stability

The Housing Stability team works with Weld County Residents who are experiencing housing instability or are at risk of homelessness. Our team provides strengths-based case management. We work with customers to help identify barriers, provide referrals to services and supports.

DHS - Outreach

The Outreach team helps Weld County families get connected to public assistance benefits and services. The Outreach Service Coordinators help explain guidelines, eligibility requirements and assist with applications. In addition, coordinators are connected and refer clients to other community programs. Upon availability of funds one time funding can be provided to assist families in crisis.

Legal Assistance



Colorado Legal Services (www.coloradolegalservices.org)

The Greeley office of Colorado Legal Services handles housing and other legal cases in Weld County. CLS assists financially eligible low-income tenants with evictions and other landlord-tenant issues. CLS attorneys can represent public and subsidized tenants who have received a subsidy or lease termination notice in administrative grievance hearings.
